Notes on Cargo Service Charges

Where the Cargo Service Charge is shown in the list as payable on the mass tonnes it shall be calculated on the gross mass tonnes of the goods.

- Mass or volume Cargo Service Charges will be levied on mass tonnes or cubic metres whichever is the greater.

Inward Cargo Storage Charges for Bulk Cargo and other Non-Containerised Cargo

Storage Charges will apply on inward cargo after three free working days from vessels departure. Terminal charges apply to vehicles. Free Period for Outward Bulk Cargo and other Non-Containerised Cargo

Goods placed on a wharf for shipment may remain on wharf free of storage while the vessel is in port and during two days before the arrival of vessel at wharf. Terminal charges apply to vehicles. Area Hire applies on Break Bulk Cargo.

Notes on Navigation Service Charges

- 1. A basic rate of \$2,013.5plus \$0.2225 per gross tonne ex GST per trading voyage within South Australian water applies. There is a 25% reduction for each subsequent call of that one vessel after the first call in a six-month period (that is, first call 100%, second 75%, third 50%, fourth 25%, fifth and subsequent ship calls no further charge). There is an option of a one-off up-front payment of 2.3 times the base charge for unlimited calls by the one vessel in a six-month period.
- 2. Rates for interstate traders, for vessels trading totally within the confines of a port and vessels not carrying cargo or passengers for reward will be subject to negotiation.

- providing, or allowing for, access of vessels to the port;
- pilotage services facilitating access to the port;
- providing berths for vessels at:
 - Port Adelaide common user berths Outer Harbor berths numbers 1 to 4 (inclusive) and 8 and Inner Harbour berths 16 to 20 (inclusive) 27 and 29;
 - Port Lincoln common user berths 6 and 7 and other berths for use in conjunction with bulk grain loader;
 - Port Pirie common user berths 5 and 7;
 - o Thevenard berths for use in conjunction with bulk grain loader;
 - o Port Giles berths for use in conjunction with bulk grain loader;
- providing access to land in connection with the provision of the above maritime services.

Current prices for the Regulated Services are set out earlier in this booklet under the headings Cargo Services Charges (ship), Navigation Service Charges (ship) and Harbour Service Charges (ship) which include mooring.

The current schedule of pilotage charges is also set out earlier in this booklet.

Our general policy for providing access to land in connection with the provision of maritime services is set out earlier in this booklet under the headings "Miscellaneous Charges" (refer sub-section "Inward Cargo Storage Charges for Bulk Cargo and other Non-Containerised Cargo" and "Free Period for Outward Bulk Cargo and other Non-Containerised Cargo") and "Area Hire Fee (Cargo)".

If you intend to ask Flinders Ports to provide you with a Regulated Service and your requests involve new capital investments, then the price information provided above may require adjustment to reflect those additional capital costs. Both parties will need to discuss such requests further in good faith.
